

Sub: Installation of CCTV cameras in JNV- reg.

Sir,

Sensing the urgent need of installation of CCTV systems for improving the facilities of safety and security of students, Samiti has allowed JNVs to utilise VVN fund to make necessary security arrangements including installation of CCTV systems vide circular F.No. 16-14/2017-NVS(SA) Dt 28.12.2017.

CBSE has also suggested for installation of CCTV systems in all along the boundary as well as some additional locations inside the premises, to monitor the movement of any suspicious person, with recording facilities. The system should also have requisite video analysis to detect any intrusion and raise an audio as well as visual alarm.

Few JNVs have installed CCTV systems in their campuses. Remaining JNVs must also install CCTV systems immediately for ensuring safety and security of students, staff and vidyalaya property.

Suggestive Guidelines are given below:-

- Quantity of CCTV cameras to be installed and general specifications.** Specifications, supply, installation, testing, commissioning of CCTV Camera alongwith storage LAN connection and other accessories required for working of CCTV surveillance system in JNVs will be decided by the Regional Office as per the actual requirement and as per Principal's request. Recording facility may be ensured for a month.
- Warranty :** Warranty of at least for the period of 3 years may be ensured.
- Annual maintenance contract (AMC):** JNVs should go for (AMC) for a period of 5 years after completion of warranty period.


d) **Number of CCTVs and suggested places**

Vidyalayas are advised to install CCTV cameras in their campuses preferably at following public places. A maximum of 21 CCTV cameras are allowed for one JNV.

1.	Main gate of the campus	01
2.	Main entrance of the school building	01
3.	Entrances of Boys hostels	04
4.	Entrances of Girls hostels	04
5.	Entrances of Mess and in the kitchen	03
6.	Four corners of the campus looking after boundary	04
7.	For staff Quarters	02
8.	Any other sensitive/threat prone areas	02

e) **Monitoring** :-It is to be done from Principal's office. An official must be designated to maintain the records. For that purpose, Chowkidars may be designated after proper training.

Sub. REVISION OF NORMS OF EXPENDITURE UNDER VIDYALAYA VIKAS NIDHI

Sir,

Detailed guidelines for utilisation of Vidyalaya Vikas Nidhi (VKN) were issued by Samiti vide its circular No.F.25-1/2009-NVS(Acad.)/805 dated 25.11.2014. In order to provide better facilities including safety and security arrangements in Jawahar Navodaya Vidyalayas, a proposal for revising the expenditure norms from VKN was prepared. The proposal was recommended by the Academic Advisory Committee in its XIX meeting held on 7th June, 2017 and is approved by the Executive Committee in its XXXV meeting held on 31st Aug 2017.

Accordingly, JNVs are allowed to utilise VKN w.e.f. 1.1.2018 for following types of expenditures in addition to expenditure norms circulated vide above mentioned circular from the Vidyalaya Vikas Nidhi (VKN):

- 1) Installation of CCTV camera in the common area.
- 2) Maintenance of CCTV in the schools.
- 3) Engaging the services of security personnel by outsourcing at the rate 2 personnel per school.
- 4) Engagement of counselors on the part-time basis as per the approved norms.

You are requested to implement revised norms w.e.f. 1st January, 2018.
